# Guidance for Coding, flagging storing and searching July 21 (refreshed appendix to guidance on completing the Quality Assured Framework)

# Merged List of Virgin Codes and proposed GP Codes

Almost all surgeries in BSW are now using Systm1 and ARDENS. The suggested codes are embedded in the ARDENS safeguarding template **but not always at the top**, as the drop-down list is in alphabetical order. The bracket indicates the drop-down box within the safeguarding template that contains the correct READ code.

Because there is some concern that when the "safeguarding relevant" box is ticked FIRST on the Ardens safeguarding template that some of these codes do not appear in searches, we recommend that you keep a separate list of patients with the READ codes that trigger payment the safeguarding contract, to enable more robust data interrogation for any possible discrepancies.

The green codes are SNOMED codes, just for background information and to try to future proof the process.

#### **Children**

- 1. Subject to Child Protection Plan XaOnx (protection plan) 342191000000101
- 2. Family member subject to Child Protection Plan XaPkF (family) 375041000000105
- 3. No longer subject to Child protection plan XaOtl (protection plan) 342891000000105
- 4. Family member no longer subject to child protection plan XaPkG (family)375071000000106
- 5. Child in Need XalO8 (Children in need)135891007
- 6. No longer on child in need plan XaIO7 (children in need)135890008
- 7. Child cause for safeguarding Concern (Code not currently used by virgin) XaZJs (concerns)836881000000105
- 8. Looked after Child XaXLt (looked after child)764841000000100
- 9. No longer looked after child XaXMD- (looked after child)764951000000107
- 10. Referral to children safeguarding team (code not currently used for children by virgin) XaXIf (referral)514341000000108

### **Adults**

- 1. *Vulnerable Adult* (code not currently used by virgin) XaKxv (vulnerable) 417430008, or vulnerable elderly person 247811000000108
- 2. Referral to Adult Safeguarding XaQok (referral) 514331000000104
- 3. History of Domestic Violence (code not currently used by virgin) XaJhe (abuse)412732008
- 4. Referral to Domestic Violence Advocate -XaNbl (abuse) 431719007
- 5. Vulnerable Adult care plan eg if under a MARM XaQmN (management care plan). 735330008 Use this for payment under the primary care safeguarding contract, e.g. when there has been a MARM for self-neglect organised or attended, or a social worker has been involved in a care plan for someone at risk of abuse. Once the plan has ended and there are no longer any safeguarding concerns this should be moved to inactive problem so it does not appear in the quarterly return.
- 6. Safeguarding Adults protection plan agreed XabzB (management care plan) 943001000000107. Use this for payment under the primary care safeguarding contract, where eg a safeguarding alert has been made, and you have had input into a safeguarding meeting, or a plan to keep a vulnerable adult safe has been agreed (whether or not it has gone on to a section42.2 enquiry). Once the plan has ended and there are no longer any safeguarding concerns this should be moved to inactive problem so it does not appear in the quarterly return.

The Safeguarding template will generate the safeguarding flag when the code is added. In order for the code to appear on the problem list an additional keystroke is required (See "how to" guide for safeguarding template)

#### **Guidance for setting up Searches**

#### Clinical Reporting>Ardens>Safeguarding

#### Adults:

**No of vulnerable adults coded and flagged:** Adults Registers > Safeguarding - Vulnerable adult (XaKXv) – *snapshot as at time of running*.

**No of referrals to safeguarding adults team:** BaNES Trust Reporting Unit>Safeguarding>Safeguarding Referrals >Referrals to safeguarding adults in the last 6 months. Search published so practices can run it on their unit for their patient cohort only. All TPP practices in BaNES are able to access these searches.

#### **Children**

**No of children coded and flagged as on CPP:** Ardens > Safeguarding > Child Registers > Child safeguarding - Protection plan (read code) – *snapshot as at date of running* 

Number of unborn children with CPP – there is an Ardens search for this- snapshot at time of running

No of children coded and flagged as on CIN: Ardens > Safeguarding > Child Registers > Child in need — snapshot as at date run.

No of children coded as LAC: Ardens > Safeguarding > Child Registers > Looked after child – snapshot as at date run

No of referrals made to children's social care in last 6 months: BaNES Trust Reporting Unit>Safeguarding>Safeguarding Referrals>Referrals to safeguarding children in the last 6 months xaXlf only,

**No of patients coded and flagged for DVA:** Ardens > Safeguarding > Adults Registers > Violence & abuse - Victim of domestic violence. This needs to be snapshot active (current) problem list only. The Ardens search looks at a snapshot based on READ codes. When the patient is no longer a victim of domestic violence, change to past inactive problem.

No of referrals accepted by IRIS in last 6months: BaNES Trust Reporting Unit>Safeguarding>Safeguarding
Referrals>Referrals accepted by IRIS in the last 6 months. No of Child in Need reports received in last 6 months: this needs to be a manual collection
