

## Statement on European Cross Border Health Care

This statement describes how NHS Bath and Northeast Somerset Swindon, and Wiltshire Integrated Care Board meets the requirements of European Directive 2011/24, and the policy published by NHS England (2013) to support access to healthcare in Europe.

### Who is entitled to NHS funding for healthcare in Europe?

NHS funding for treatment in the European Economic Area (EEA)<sup>1</sup> will be provided for patients who are entitled to NHS care if:

- Their GP/NHS clinician recommends the treatment.
- The patient meets the local NHS's treatment criteria.
- The cost of treatment in Europe is equivalent or less than the cost of NHS treatment.

### What treatments will be funded?

NHS funding for treatment in Europe will not normally be provided for 'low priority' treatments; Clinicians/patients seeking NHS funding for these treatments must apply through the Individual Funding Request process: see:
